

BizInt Solutions Inc. End User License Agreement
BizInt Smart Charts for Patents Software, Version 3.3 for Windows for One
Authorized Workstation and Related Documentation

1. GRANT OF LICENSE. This License Agreement (the "Agreement") grants you (the "Licensee") the following rights with respect to the use of the BizInt Solutions Inc. Software program identified above (the "Software"):

(a) Workstation Software: This product package includes Software designated as Workstation software; you may use such Workstation software on a single computer or workstation. For purposes of this section, "use" means loading the Software into RAM, as well as installing on a hard disk or other storage device. You may access the Software from a hard disk, over a network, or any other method you choose, so long as you otherwise comply with this Agreement. If any licensed copy of the Workstation software is installed on the hard disk or other storage device of a computer and one person uses that computer more than 80% of the time it is in use, then that person may also use the Workstation software on a portable or home computer.

If you receive a version of the Software that is an update, any transfer must include the update and all prior versions.

(c) USE OF THE SOFTWARE IN CONJUNCTION WITH ANY ON-LINE DATABASE HOST ("HOST") IS SUBJECT TO ANY AND ALL TERMS OF THE LICENSE BETWEEN THE HOST AND LICENSEE. NOTHING IN THIS AGREEMENT AUTHORIZES LICENSEE TO MAKE ANY USE OF THE SOFTWARE THAT IS INCONSISTENT WITH OR NOT PERMITTED BY LICENSEE'S LICENSE FROM THE HOST.

2. COPYRIGHT. All title and copyright in and to the Software and all accompanying written materials is owned by BizInt Solutions Inc. and is protected by United States copyright laws and international treaty provisions. Therefore, you may not copy the Software, except that you may make one copy of the Software solely for backup or archival purposes. You may not copy any of the written materials that accompany the Software.

3. OTHER RESTRICTIONS. This Agreement is your proof of license to exercise the rights granted herein and must be retained by you. You may not reverse engineer, decompile, or disassemble the Software.

Any replacement Software will be warranted for the remainder of the original warranty period or thirty (30) days whichever is longer.
